We understand the COVID-19 pandemic has greatly impacted the education system and continues to present significant challenges for many of our Team Advisors and student participants. eCYBERMISSION wants to help ease some of those challenges and remove a few of the barriers students and Team Advisors are encountering while participating in eCYBERMISSION this year due to virtual learning challenges and social distancing requirements.

We are pleased to announce two accommodations to our rules for this year only in light of the COVID-19 pandemic:

- <u>Team Make Up</u>: a complete team can now include two, three or four students
- <u>Mixed Grade Teams</u>: Students from different grades (6-9) may form a team. However, the students will compete at the highest grade level. For example, two 6th graders and an 8th grader may form a team, but will compete at the 8th grade level.
